Personalities from multilateral environmental organizations, ministries of the environment, NGOs, prestigious figures, researchers, professors, businessmen, new economic actors, and producers in general will participate in the activities.

Those interested in presenting their contributions to the topics of the Congress will do it through oral presentations and posters.

Oral papers will have around 15 minutes for the presentation and discussion and they will be organized according to the approved type of modality: panels, round tables and special thematic sessions. The papers on posters will be exhibited in a designated area for the posters presentation, which will be presented in a format of 95 cm (horizontal width) and 150 cm (vertical length).

ABSTRACTS AND PUBLICATION OF PAPERS

Participants interested in making presentations, oral or in posters, must send an abstract in Spanish, English or Portuguese language to the e-mail cga@geotech.cu and igtcuba@gmail.com, copying convencion@ama.cu.

In the body of the e-mail the author must indicate the congress in which wants to expose the work and the form of presentation proposed. The author may request the Scientific Committee the modality of its presentation (oral, poster); however, this shall preserve the right to define it and will communicate it to the author in a timely manner.

Each approved work will be notified to its author and will be assigned within the scientific program the day and time of its presentation. The author will be present at the appointed time to answer possible questions from the participants.

The summaries of Cuban and foreign participants must be sent to the Organizing Committee before **April 15th, 2023**. The Organizing Committee will make the selection and will inform the authors about the accepted abstracts before **April 30th, 2023**, preserving the right to decide the form of presentation, which will be informed to the authors.

In the case of more than one author, the name, country, institution and e-mail of each author will be entered.

Publication Opportunity in the Memoirs of the Congress

The Organizing Committee will publish, in full length and in electronic format with ISBN, the works of the authors who request it. The authors interested must send the works before **May 20th, 2023** once the acceptance of the abstract has been communicated.

The works sent after that date will not be guaranteed their publication in the memoirs of the event.

Publication Opportunity in the Cuban Journal of Geography

Additionally, those interested in publishing a scientific paper in the Cuban Journal of Geography must comply with its editorial policy.

The original works that have not been presented, published, or are under evaluation in other events or scientific journals, will be evaluated, based on their relevance, originality, importance and clarity, for publishing as research papers in one of the editions of the Cuban Journal of Geography. Scientific papers must have:

- Title in Spanish and English (up to 15 words)
- Authors
- Author affiliations and author email for correspondence
- Abstract (up to 250 words)
- Keywords (up to 5 words)
- *Abstract*
- *Keywords* (up to 5 words)
- Introduction
- Materials and methods
- Results and Discussion
- conclusions
- References

They will be contained in ".docx" files from the Word word processor, with a paper size of 8.5 x 11 inches, and 2.5 cm margins. For its conformation, the 12-point Arial font must be used, with 1.5 spacing, in a single column.
